

Affine Springer fibers, Cherednik algebras and Hilbert schemes

The aim of this reading group is to introduce the participants to some of the basic objects of the affine Springer theory and connections of this theory to Hilbert schemes of points on surfaces, Cherednik algebras and knot homologies.
